Seeking Nominations for Karbeling Award

Each Fall, the Iowa Rural Health Association recognizes an outstanding individual in the area of Rural Health by presenting them with the Jerry Karbeling Award. We are now accepting nominations for the 2016 Jerry Karbeling Award. **Nominations are due October 3, 2016.**

Jerry Karbeling was a member of the Iowa Rural Health Association and served on the Board for 5 years. He served as President of the Association in 2002-2003. At the time of his death in 2005, Jerry was the Senior Vice President for Public Affairs and Corporate Development for the Iowa Pharmacy Association, a practicing community pharmacist, and owner of Big Creek Pharmacy in Polk City. He was a healthcare activist, an adjunct professor, and served on the City Council of Polk City.

The Iowa Rural Health Association seeks to recognize Jerry's legacy and to retain the memory of his contributions. The Jerry Karbeling award will be presented to an Iowan on an annual basis. The award will recognize an individual who has demonstrated successful activism for improving rural health and a commitment to community service as exemplified by Jerry.

The individual's contributions should include:

- 1. Respected leader in the healthcare industry;
- Community oriented as evidenced by serving on boards/committees, for the purpose of advancing a healthy lifestyle;
- 3. Activist as identified by participation and enthusiasm in developing public health policy.

The letter of nomination should include documentation to the above three categories, and be accompanied by 3 letters of support speaking to the nominees effectiveness as a health leader, a community minded individual, and previous policy contributions at the local, state, or national level.

Iowa Mission of Mercy Coming to Dubuque, Iowa, for the first time!

Another year has passed, and it's time for the ninth Iowa Mission of Mercy! When we began in 2008, no one knew just how successful the Iowa Mission of Mercy would be. That year, the local chair, Dr. Marty Averill, noted, "would anyone come?" Well, he had nothing to fear. Not only did they come in 2008, but they have been coming ever since to the tune of 10,700 patients!

This year Dr. Heyo Tjarks, a long-time Dubuque dentist, decided to chair the Iowa MOM in Dubuque, Iowa. The ninth Iowa Mission of Mercy will be held September 23 & 24 at the Five Flags Center. We hope to treat over 1,200 patients at the 2016 event.

While much has changed about the Iowa Mission of Mercy since that first year, what has not changed is the need for services like the Iowa Mission of Mercy. Barriers to receiving oral health care still exist. The greatest barriers for individuals not receiving the care they need continue to be lack of dental insurance and insufficient funds to pay for care on their own.

According to a Harris poll conducted in 2013, 48% of lower income adults haven't been to the dentist in more than a year. Further, 20% of adults earning less than \$30k haven't visited a dentist in over 5 years. Thirty six percent (36%) of lower income adults have lived with an untreated cavity for some time causing pain. Emergency rooms are finding more individuals seeking treatment for oral health care. According to the same Harris poll, 18% of lower-income people sought treatment for dental pain in an ER; however, only 6% of those who went were able to have their dental problem solved.

According to the Surgeon General's Report on Oral Health in America, oral diseases affect health and well-being throughout one's life. Research links periodontal disease to a greater risk of heart attack and stroke. Research conducted by New York University in 2010 revealed long-term evidence that linked gum inflammation and Alzheimer's disease, finding that gum disease could increase the risk of cognitive dysfunction. Both children and adults can experience difficulty eating and speaking due to dental

disease and many suffer from diminished self-esteem from visible tooth loss. Oral health care is one of the most-often-reported unmet health care needs in the United States.

I appreciate small town life and the sense of community that it provides to residents. I was raised in small town Iowa and I knew after graduating from school as a dental hygienist that I wanted to settle down and raise a family in a close-knit, rural setting, just like my community of Monroe, Iowa. For the last 11 years I have worked as a dental hygienist in the Pella/Knoxville community, with the 8 most recent years focused on public health as part of the I-Smile™ program. Working with I-Smile™ opened my eyes to the real struggles many families face when trying to access dental care in rural settings. It can be difficult for families and local public health workers to find dental providers, transportation, and community resources to assure access to dental care. Unfortunately, many families must be referred to an urban setting, an hour or more away, in order to get the care they need.

After joining the IRHA board in January 2015, I was elated to find a passionate group of individuals who understood and cared about the different challenges that rural patients and health care providers encounter when trying to achieve optimal health. I found many opportunities within IRHA to grow personally and professionally. Here are just a few of the many reasons why I cherish the experience of being an IRHA member.

- **Legislative updates**....these appear in the quarterly newsletter and are my quick "go to" for policy information that may affect the programs and populations I work with.

Back to School: Are Your Patients Ready?

School bells are ringing across the state! The end of summer is here, filling practitioner schedules with physicals and screenings, making sure that students have a healthy start for the upcoming school year. Unfortunately, dental appointments are often overlooked or difficult to access for many Iowans, including school-age children. For kids, this can lead to decreased time in the classroom for learning throughout the year ahead. According to the Surgeon General's Report in 2000, more than 51 million school hours are lost each year due to dental-related illness; a number Iowa has been trying reduce.

In 2007, legislation was passed requiring children entering Kindergarten and 9th grade in Iowa to have a dental screening upon enrollment. The goal is the improved oral health of children, early detection of dental problems, and promotion of the importance of oral health for school readiness and learning.

How can medical providers get involved?

- Encourage patients to visit the dentist regularly
- Provide a dental screening as part of a routine physical
- Complete a school screening certificate for children who will be in Kindergarten
- Refer children with dental care needs to the local I-Smile™ Coordinator
